

## USER/VISITOR PERSONAL DATA PROCESSING CONSENT

### TERMS CLARIFICATION:

**WEB-BASED PLATFORM «ERTC»** (HEREINAFTER REFERRED TO AS «WEBSITE», «SERVICE») – REGISTERED IN ACCORDANCE WITH THE STATE LAW OF GEORGIA, LEGAL ENTITY GENESIS 2.0 LLC, IDENTIFICATION NUMBER 445542495. OPERATES UNDER THE COMMERCIAL NAME (BRAND) "ERTC";

**PERSONAL DATA (HEREINAFTER REFERRED TO AS – DATA)** – ANY INFORMATION RELATED TO AN IDENTIFIED OR IDENTIFIABLE INDIVIDUAL.
